## RRYCC Rules & Regulations

1. There is no assigned parking for cars. Two vehicles per unit. Each unit may park 2 Passenger vehicles at the unit for persons staying in the unit. Extra Vehicles may be parked in boat parking.
2. All boats must be parked in boat parking lot and may be washed at boat wash station in boat parking only.
3. No fireworks allowed on RRYCC property including the pier & marina areas.
4. BBQ pits must be placed 10 ft. from wooden deck.
5. Household garbage must be bagged, tied and placed in dumpster.
6. No bicycles, skateboards, skates, scooters, or motorized vehicles allowed on sidewalks, tennis courts and pier/marina area.
7. Swimming pool hours are 9:00 am - 10:30 pm. Please follow rules posted at the pool gate. Do not put pool furniture into the pool. Do not remove pool furniture from the area. No loud music or horseplay allowed. Children under 12 must be accompanied by an adult. No Glass bottles allowed at pool.
8. No children under 12 allowed on the pier or the marina area without an adult.
9. All pets must be kept on a leash and owners must clean up after them when outside.
10. No Parking on Grass
11. Be aware that the use of all RRYCC facilities are at the owners', their guests and renters, **SOLE RISK AND RESPONSIBILITY**. Any owner's guest or renter may be denied access and/or be removed from the property if not following the rules and policies of the RRYCC. Also, be aware the RRYCC has issued a statement concerning the use of all RRYC during the COVID – 19 pandemic – a copy of which has been provided to the owners and rental companies.
